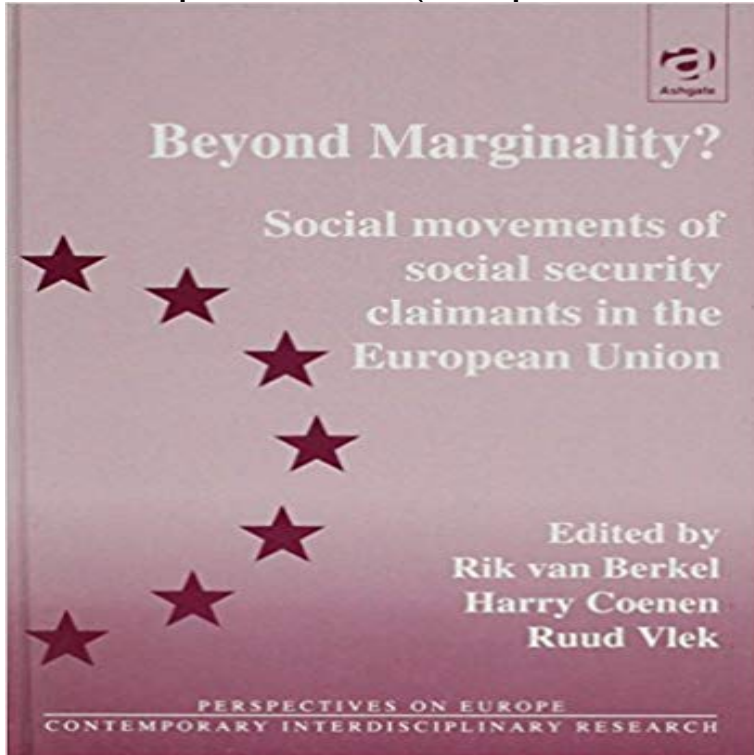


Beyond Marginality: Social Movements of Social Security Claimants in the European Union (Perspectives on Europe Series)

The strengths and weaknesses of these organizations are analyzed from a variety of theoretical perspectives such as the opportunity structures of welfare states and national political relations, the fragmentation of social movement along ideological and categorical lines, and the problems of organizing social groups.
